## TIMING, MODE AND OPTIONS

### AUTO Option

When using the AUTO option the LightWorks is timed for 3 minutes on each of the 8 Modes for a total of 24 minutes.

### MANUAL Option

When using the MANUAL option, all Modes are timed for 20 minutes when selected.

## ELECTRICAL SPECIFICATIONS

### LIGHT OUTPUT SPECIFICATIONS

**Orange LED lights:** Features 60 high-intensity Orange LED lights with a wavelength of 602 nanometers (nm) (+/- 10 nm) and a light output of approximately 309 milliwatts (mW)\*.

**Yellow LED lights:** Features 60 high-intensity Yellow LED lights with a wavelength of 590 nanometers (nm) (+/- 10 nm) and a light output of approximately 166 milliwatts (mW)\*.

**Green LED lights:** Features 60 high-intensity Green LED lights with a wavelength of 525 nanometers (nm) (+/- 10 nm) and a light output of approximately 331 milliwatts (mW)\*.

**Blue LED lights:** Features 60 high-intensity Blue LED lights with a wavelength of 470 nanometers (nm) (+/- 10 nm) and a light output of approximately 662 milliwatts (mW)\*.
